

WAIVER OF LIABILITY AND RELEASE OF CLAIMS

5. **Governing Law.** This Waiver shall be governed by and construed in accordance with the laws of the Republic of the Philippines. Any disputes arising hereunder shall be resolved exclusively in the courts of [specify jurisdiction, e.g., "the City of Manila"].
